By signing this contract I am agreeing to exhibit at the Berkeley Blueways Paddlefest on Saturday, April 8th at the Old Santee Canal Park and to the provisions herein.

1. The event will open to the public at 10:00 am and close at 5:00 pm on Saturday, October 4, 2008. Sunday, October 5th will be exclusively for guided trips by outfitters at other locations. No exhibits will be at the park on Sunday.
2. There is no cost for exhibit or booth space which is available on a first come basis. Exhibit spaces are 20' X 20' of asphalted lot with adjacent grassed area.
3. Exhibitors may begin to set up booths when gates open at 8:00 a.m. Exhibits should be open for business from 10:00 am to 5:00 pm after which they should be removed unless other arrangements have been made.
4. The lessor nor any of the agents will be responsible for any loss, or injury that may arise or come to the lessee, his employee, his family, or his goods.
5. The lessee agrees to limit his exhibits to items that are defined suitable to the character of the festival. The lessor maintains all rights as to suitability.
6. Lessee shall not sublease or share his booth with anyone without the permission of the lessor.
